Privacy Notice for Autosource Mobile

EFFECTIVE DECEMBER 31, 2019

This notice of **Autosource Mobile** (referred to as "**Audatex North America, Inc.**", "we", "us" or "our" in this privacy notice) explains how we collect and process personal data through your use of Autosource Mobile. This notice should be read in conjunction with our Privacy Policy. Solera respects your privacy and is committed to providing information about personal data collected and processed by our company. This privacy notice may be updated by us from time to time.

Our application is not intended for minors under the age of 16 and we do not knowingly collect data relating to children.

COLLECTION OF PERSONAL DATA

This service collects personal data, such as information you provide including names, addresses, telephone numbers and IP addresses. This App will also collect, use, store and transfer information about vehicles such as their VIN, license numbers, manufacturer and model and information about your mobile device such as its operating system type and version. We do not collect sensitive personal data. We may have received your name and contact information from the Autosource customer that authorized your access to the Autosource service. We collect, use and share **Aggregated Data** such as statistical or demographic data for any purpose. Aggregated Data may be derived from personal data but is not considered personal data in law as this data does **not** directly or indirectly reveal a person's identity.

We will use the personal data we collect to ensure that you are an authorized user of the App and for providing contractual services to our Autosource customer that authorized your access. We may also process the data for legitimate purposes such as defending, establishing or exercising legal claims. If you fail to provide required personal data, you will not have access to services through the App.

We will only use personal data for the purposes for which we collected it, unless we reasonably consider that we need to use it for another reason and that reason is compatible with the original purpose. If you want an explanation as to how the processing for the new purpose is compatible with the original purpose, please contact us.

We do not sell personal data as those terms are defined under the California and Nevada data protection laws.

This service collects the following types of personal information for the purpose shown below:

- Identification Data includes data such as a name, alias, postal address, unique personal identifier, online identifier, email address, account name, social security number, driver's license number, passport number, or other similar identifiers.
- **Commercial Transaction Information** includes data such as records of personal property, products or services purchased, obtained, or considered, or other purchasing or consuming histories or tendencies.

Aggregated Data, such as statistical or demographic data, may be derived from your personal data but is not considered personal data in law as it does **not** directly or indirectly identify you.

IF YOU FAIL TO PROVIDE PERSONAL DATA

Where we need to collect personal data to provide this service or where required by law and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter into with you (for example, to provide you with services). In this case, we may have to cancel a product or service you have with us, but we will notify you if this is the case at the time.

DATA SECURITY

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors and other third parties who have a business need-to-know. They will only process your personal data on our instructions, and they are subject to a duty of confidentiality.

We have put in place procedures to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so.
